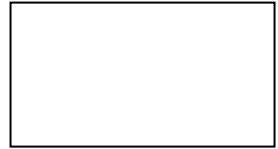

**GENERAL DECLARATION**  
**FOR COMPLETION BY ALL COMPETITORS**

**I declare that:**

- 1) I have been given an opportunity to read the General Regulations of the Motor Sports Association (MSA) and, if any, the Supplementary Regulations for this event and agree to be bound by them. I declare that I am physically and mentally fit to take part in the event and I am competent to do so. I acknowledge that I understand the nature and type of the competition and the potential risk inherent t with motor sport and agree to accept that risk. Further I understand that all persons having any connection with the promotion and/or organisation and / or conduct of the event are insured against loss or injury caused through their negligence.
- 2) To the best of my belief the driver(s) possess(es) the standard of competence necessary for an event of the type to which this entry relates and that the vehicle entered is suitable and roadworthy for the event having regard to the course and the speeds which will be reached.
- 3) The use of the vehicle hereby entered is covered by insurance as required by the law which is valid for such part of this event as shall take place on roads as defined by law.
- 4) I understand that should I at any time of this event be suffering from any disability whether permanent or temporary which is likely to affect prejudicially my normal control of the vehicle. I may not take part unless I have declared such disability to the ASN, who have following such declaration, issued a licence which permits me to do so.
- 5) Any application form for a licence which was signed by a person under the age of 18 years was countersigned by that person's Parent/Guardian/Guarantor, whose full names and addresses have been given.
- 6) If I am the Parent/Guardian/Guarantor, of the driver I understand that I have the right to be present during any procedure carried out under these Supplementary Regulations issued for this event and the General Regulation of the MSA. As the Parent/Guardian/Guarantor, I confirm that I have acquainted myself with the MSA General Regulations, agree to pay any appropriate charges fees to those Regulations (to include any appendices thereto) and hereby agree to be bound those Regulations and submit myself without reserve to the consequences of those Regulations (and any subsequent alterations thereof). Further, I agree to pay as liquidated damages any fines imposed upon me up to the maxima set out in Part 3 Appendix 3.
